

Environmental Activity Sector Registry Services

The Ministry of the Environment and Climate Change ("MOECC") has finalized a new regulation, requiring certain facilities to register their activities related to air and noise emissions on the province's Environmental Activity and Sector Registry ("EASR").

When do I need to do this? After December 31, 2016, if you make changes to your current emission related operations or if you install new equipment that have emissions, you must determine if your Facility is required to register for an EASR to replace your current ECA.

What are the requirements for the EASR process?

- 1. Assess all emissions from the facility.
- 2. Assess all substances that have no MOECC limits.
- 3. Assess noise and odour emissions.
- 4. Develop and implement noise and odour mitigation control plans (i.e. odour control reports), if required.
- 5. Develop maintenance and operational procedures, complaints and record management requirements.
