

CASF President's Newsletter – June 2020

Dear CASF Member and Industry Supporter:

As I write this late on June 11, 2020, I'm watching the DOW drop 1800 points, the TSX here in Canada dropping 600 points along with most major stock markets in the world. This is scary but I'm sure tomorrow will bring good news again. As of yesterday, the DOW has regained 71% of its drop from its all-time record high level before the pandemic; the S&P 500 has regained 76% and the TSE is back up 62% and all of them could be back to pre-Covid levels by year end or sooner. This is good news for all of us worried about our RRSPs, investments and just getting by! Right now we are either coming out of Covid-19 or getting ready for the next wave which is predicted to be worse than the first, and all of us are living through an upheaval unprecedented in our lives, the extent of which will not become apparent until much time has passed.
